Tournament Rules and Regulations

MIXED DOUBLES

1. This tournament is open to all TNBA and USBC members, and will be operated under the tournament rules of USBC and TNBA. Unsanctioned USBC bowlers may participate in the tournament by purchasing unattached USBC membership cards. Any entrant who does not hold or has not applied for TNBA membership prior to bowling will be disqualified. Unattached TNBA membership cards may be purchased at the site at a cost of \$25.00. USBC Associate Membership cards may be purchased at a cost of \$21.00.
2. Advanced entries close midnight October 1, 2013. Final Entries and re-entries will close at last squad, Sunday November 3, 2013.
3. All fees, in the form of money orders or certified checks ONLY for pre-entries, or cash (at the tournament site ONLY), must accompany the entry blank. No fees will be refunded. Entry blanks must show the full names and addresses of each bowler. Any entry blank improperly filled out, improperly verified, or with missing signatures, averages, or the improper amount of fees will not be accepted, but will be returned to the sender, at the discretion of the Tournament Director.
4. Teams shall be composed of one man and one woman.
5. **PBA members of any division are NOT permitted to bowl in this tournament. Former PBA members who have not held a card for the past two (2) years are eligible to bowl in TNBA tournaments.**
6. Bowlers must use their highest average based on a minimum of 21 games for the 2012-2013. If no average for last season use highest current sanctioned average for 21 or more games as of October 31, 2013 verified by league. All others bowl scratch. Do not use Summer League averages. **Ten pin rule is waived.**
7. It shall be each bowlers responsibility to verify the accuracy of his or her average in handicap or classified tournaments, whether originally submitted by the bowler, his or her team captain or others.
Failure to use the proper average shall disqualify score if submitted average is lower than actual average thereby resulting in a lower classification or more handicap. Prize winnings shall be based on the submitted average if it is higher than the actual average (Handicap only).
7. In the case of teams of two or more bowlers, the handicap shall be combined to determine whether the correct total is higher than submitted total.
8. Any protest pertaining to the prize fund results must be received and postmarked within ten (10) days after the distribution of the tournament results.
9. Scores bowled in the Mixed Doubles Tournament DO NOT APPLY TO ALL EVENTS. This is a separate tournament.
10. The handicap shall be 80% using 220 scratch. Bowlers will certify their scores as being correct at the completion of each game. Handicap is on an individual basis.
11. The Tournament Director reserves the right to accept or reject any substitute. Once a substitute has been made and upon the sub rolling the first ball, that sub MUST COMPLETE THE SERIES OF GAMES IN PROGRESS, except in the case of injury or disability.
12. MULTIPLE ENTRY: Bowlers may enter the Mixed Doubles as many times as they wish except that you may cash only once with the same partner (highest score to count), but as many times as you are on the prize list with a change of partners.
13. Entrants who have qualified for a prize of \$600 or more in any event in a Tournament within the previous 12 month period shall, prior to bowling any event, report to the Tournament Director the actual score, position won, and amount of prize for possible re-rating. Any re-rating will be done prior to the entrant bowling. **Any entrant having been re-rated or subject to re-rate by another tournament must report their re-rated average to the tournament director, failure to do so will result in disqualification.** USBC Rule NO. 319E APPLIES to both male and female entrants.
14. Entrants shall report for check in at least one hour before scheduled starting time and shall present their USBC and TNBA cards upon request.
15. Entries will be scheduled as received and when more than one choice is shown, only those times indicated will be considered. However, when dates and times are assigned by the Tournament Director and not refused by the person responsible for submitting the entry prior to preparation of the schedule. NO FEES SHALL BE REFUNDED.
16. Entrants who place on the prize list MUST HAVE THEIR AVERAGES VERIFIED by the local association secretary or printout from Bowl.com, and sent to the Tournament Director. Failure to do so will result in disqualification and the next position will move up. It is requested the VERIFICATIONS BE SENT WITH THE APPLICATION BLANKS. The Tournament Director reserves the right to disqualify any entrant not in compliance with the rules of the tournament, USBC and/or TNBA. Premature termination of the tournament brought about by war, national emergency or emergency causes relating thereto or fire, natural disaster or any other reason beyond the control of the TNBA Western Regional Tournament shall cause, the extent required hereby, all prizes to be prorated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination.
17. Proper attire required. No head gear (hat, cap, etc.). The Tournament reserves the right to final decision on proper attire.
18. There will be at least one (1) prize for every ten(10) entries.
19. Anyone working in the host bowling center may not bowl in this tournament.
20. Tournament committee reserves the right to disqualify any bowler not in compliance with the rules of the tournament.
29. This tournament will be operated under the rules of TNBA and USBC. Any bowler failing to verify his/her averages by November 18, 2013 will be DISQUALIFIED. No exceptions or excuses. **Any bowler winning \$600+ will be issued an IRS W-9 BEFORE any prize winnings are paid to that bowler.**
